# Message from Your President



Thanksgiving is an occasion when we gather together and, regardless of the circumstances or the challenges we faced over the past year, we collectively give thanks for what we have.

There are many things that I'm thankful for from a union perspective. I'm thankful that I have a contract through 2018. I'm thankful that my new contract will allow for salary increases. I'm thankful that my contract allows me to take sick days when I'm sick or need to care for a loved one. I'm thankful that I have access to great medical coverage for myself. I'm thankful that I have planning and conference time built into my day so I can meet with other teachers and plan lessons. I'm thankful that I have access to an

Employee Assistance Program, Impact, which allows me to reach out for help if my life becomes too stressful. I'm thankful that I have access to a Sick Bank if something catastrophic happens in my life. I'm really thankful that I have the right to bargain all of these items mentioned above. If you take advantage of any of these benefits, you can thank your union ... the MEA!

Recently, there has been a lot of talk about Teacher Evaluation. I'm thankful that the Ohio Senate has started to see major problems with the Teacher Evaluation System. As you know, our school district is currently piloting the Mayfield Teacher Evaluation System (MTES). The pilot is progressing well and many pilot members feel the system is focusing on growth in the teaching profession. This past week, Senator Peggy Lehner, the chair of the Senate Education Committee, introduced Senate Bill (SB) 229. This bill calls for three major changes to the evaluation process.

Change #1: SB 229 reduces Student Growth Measures (SGMs) from 50% to 35% that would be applied to a teacher's overall evaluation.

Change #2: Teachers, who receive the highest rating available, *Accomplished*, were originally given the benefit of being evaluated every other year, but SB 229 increases that to once every three years.

Change #3: SB 229 changes the requirement for a *Skilled* teacher from an annual evaluation to one that would occur every other year.

"It's encouraging to see these types of reasonable changes occurring in the Senate Education Committee where much of the process has been driven legislatively, as it reflects a willingness to dial back some of the overbearing requirements in a manner that benefits schools, even if only for correcting the ridiculous amount of time principals and teachers would have spent on the process." Typically when new bills are introduced in the Ohio Senate or House, they are not favorable to public education. They are typically introduced by elected officials who know very little about what is happening in schools. It is promising to see some rational thought coming out of this bill. I am hopeful that it will move forward.

So on this occasion, I thank you for being part of our MEA family and wish you and your loved ones a Happy Thanksgiving.

## Here is an example letter- Thank you to Elizabeth Scully, 4<sup>th</sup> grade teacher at Millridge Elementary School.

Dear Senator Eklund,

I urge you to support your colleagues' Bill 229. I have been very involved in teacher evaluation in my district for the last several years and I am a 4th grade teacher who teaches both reading and math. This makes me one of those "value added" teachers whose students' scores account for 50% of my evaluation. I have been teaching for about 23 years in both public and private schools. I have my Masters in Reading and Literacy and my Principal's Certificate in Educational Leadership. I continue to be involved in my school's Building Leadership Team as well as my district's Evaluation and Assessment teams and I am currently piloting my district's teacher evaluation system. I teach students who have RIMPs and IEPs and WEPs. I have special needs students who are learning disabled, hearing impaired, ADD, ADHD as well as Gifted. I am a Master Teacher as designated by the State and my district and yet there are limitations to what I can achieve with some students whose daily needs supersede that which I am working non-stop to help all of these students achieve to the best of their abilities. I believe 35% is more realistic than 50% to account in my evaluation as we begin to implement the Common Core in the State of Ohio. Please vote to drop the student scores impact on my evaluation from 50% to 35% as we proceed to implement the Common Core. It is unconscionable that we all agree that there will be a drop in scores as we implement the Common Core and vet hold teachers to this 50% of their evaluation standard. Please value the work we do daily in our classrooms and know that we work nonstop to help our students achieve.

For example, if you are taking leave for Sick Leave>Self, write Sick Leave>Self. You are not required to give any more information, unless it is required by your contract. (Example: Day prior to a holiday.)




