## A Message from our MEA PRESIDENT

Dear MEA Members:

I hope that your year is off to a great start. We just started the first year of our new contract, yet I would like to take a moment to highlight some of the continuous contract work of the MEA.

As I have mentioned in some of my emails, the MEA has contract committees who will be working on the following charges this year:

#### Health Care

Charges:

- Continue to explore and develop wellness programming in consultation with Oswald Wellness specialist, Wildcat Sport and Fitness, and employee health data.
- Review cost trend data to determine program viability with respect to potential changes.
- Monitor the biometrics screening program at the Mayfield Health and Wellness Center operations and personal physician sign-off to determine opportunities for improvement.
- Look for additional opportunities at the Wildcat Health & Wellness Center outside of biometric screening process:
  - $\circ~$  Onsite physicals and/or healthcare options for staff 4 dependents in the absence of a primary care physician.
  - o Concierge healthcare program--24 hour call-in program.
  - o Improve visibility of center with school building outreach.
  - o Evaluate current hours of operation, utilization, plus/delta.
- Monitor member satisfaction with the new management company.

#### Teacher Evaluation

Charges:

• Address and communicate legislative changes impacting teacher evaluation including but not exclusive to the following: student growth measures, shared attribution, vendor assessments, ETPES, potential integration of resident educator and teacher evaluation.

- Monitor implementation of iObservation and teacher performance with a focus on progress in consistency.
- Investigate switching to OTES.
- Monitor and gather feedback on newly created instruments, especially the new Ohio Counselor Evaluation System.
- Review and discuss how technology (the use and nonuse of it) impacts a teacher's evaluation.

#### Technology

Charges:

• Review and suggest to the DLT professional development plans for the District's newly acquired technologies and platforms like Schoology, Illuminate, etc.

#### Supplemental

Charges:

• Monitor placing proposed/experimental clubs into the contract.

#### Special Ed

Charges:

- Monitor staff ratio as outlined by ODE and compare it to how we serve our special education population.
- Create a database or use AESOP to monitor how often intervention specialists and tutors are used as a substitute in the classroom. Send this report to the DLT on a semester basis.
- Develop a Paraprofessional Handbook.
- Assess if a building assistance team (BAT) is in place at all buildings.

Thank you to everyone who has signed up to serve on one of these committees. I have asked the cochairs to send a summary of each quarter's meeting and the group's progress on these charges. These summaries will be included in our monthly newsletters.

#### Information Needed for Reimbursement

- This completed Reimbursement Form

- If you paid an annual membership fee, that amount will be divided by 12 to determine monthly fee (i.e. \$240 annually/12 months = \$20 per month fee)
- Documentation from the club, facility or program showing amount of visits within the month (a minimum of 12 visits per month is required for reimbursement)
- If your club, facility or program cannot provide a printed report showing the number of visits per month, you may
  submit documentation with facility signature in lieu of a facility report
- Documentation from the club, facility, program or event showing dates of contract and member(s) enrolled

#### Certification/Authorization (This form must be signed and dated by the subscriber)

Reimbursement is subject to approval by the Program Administrator, Oswald Companies. Please submit any receipts for reimbursement by the 10<sup>th</sup> of the month in order to receive reimbursement by the end of the month. There are no retroactive reimbursements.

#### NEA Representative Assembly:
